




## THE OHIO CONSTITUTION

The General Assembly shall make such provisions, by taxation, or otherwise, as, with the income arising from the school trust fund, will secure **a thorough and efficient system of common schools throughout the state;** but no religious or other sect, or sects, shall ever have any exclusive right to, or control of, any part of the school finds of this state.

## **OUR PROBLEM**



#### ALL IN FOR OHIOKIDS

- For a long time, lawmakers didn't follow the constitution. The Ohio Supreme Court said so FOUR TIMES!
- Ohio school funding relies heavily on property taxes - disadvantaging communities with low property values disproportionately harming Black & brown districts, rural areas, people with low incomes.
- Amid rising property values, voters are fatigued. Half of school levies failed last fall.
- Speaker Huffman and his allies have expanded vouchers, costing \$1 Billion, and want to do more.



## **OUR SOLUTION**

Fully Fund the Fair School Funding Plan:

- No more guesswork: Requires the state to fund the schools based on the actual cost of educating children.
- Targets dollars where they're needed: The plan helps all kids, but prioritizes the most in need – like disadvantaged communities and kids with special needs.
- **Provides local relief:** Reduces the need for local levies.



### House Plan scraps FSFP, underfunds schools by \$2.75 billion

Under the House Plan, schools will receive just 10% of what they need.

This will shortchange Ohio's public schools by \$2.75 billion in needed funding in just two years.

### House Plan

- **Fair School Funding Formula Eliminated:** The state has removed the Fair School Funding Formula, which provided a balanced way to fund schools. No new formula has been introduced to take its place.
- **Minimal Increase in State Funding:** The proposed increase in funding from the state is too small and does not make up for the loss of local tax revenue.
- Harmful 30% Carryover Cap: A 30% limit on how much money districts can carry over—based on last year's spending—creates instability and doesn't reduce dependence on local property taxes.
- **Risk of Frequent Levy Cycles:** The cap may force districts into a cycle of asking voters for new levies every year or every other year just to maintain essential services.
- **Shifts Tax Burden to Schools:** While the funding model may provide short-term property tax relief for residents, it does so by putting all the financial pressure on public schools.
- Loss of Local Control: Takes away local decision-making by handing school budget authority to the County Budget Commission, instead of letting local communities decide.
- Loss of Elected State Board of Education: Would cut all elected members of the State Board of Education and limit the board to five appointed members.

to this district over the next two years.


The House plan is based on what politicians want, not what children need. It would provide an additional

### \$492,987

to this district over the next two years, in the hopes that an increase over the biennium will distract from the long-term instability and underfunding their plan ensures well into the future. By scrapping the FSFP, the House would end Ohio kids' best chance at fairly funded public schools.

## The House Plan would shortchange **CHUH** by \$6,609,639 over the next two years.






# So what can we do?

# **BUDGET 101**

- January 31st: Governor introduced budget framework to spend state revenue (our tax dollars)
- They have BILLIONS, and it must be balanced
- Feb early April: House sessions (concluded)
- Late April mid-June: Senate sessions
- Mid-June: Conference committee reconciles the two versions of the bill
- Full floor vote by June 30th






